Benjamin Freedman’s historic 1961 speech at the Willard Hotel in Washington DC. 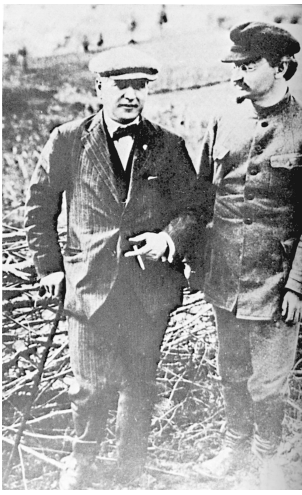

**A 1938 Stalinist police interrogation** of a founder of the Communist International, [Christian G. Rakovsky](#), 65, facing execution for plotting to overthrow Stalin, laid bare the plot for Jewish banker world tyranny.

The 50-page transcript of his interrogation, dubbed “[The Red Symphony](#),” was not meant to become public. It confirms that the Rothschild-Illuminati plan to use Communism to establish a world dictatorship of the super rich.

This is perhaps the most explosive political document in modern history. It reveals why the Illuminati created Hitler and then sought to destroy him, and why Stalin made a pact with Hitler in 1939.

[Christian Rakovsky](#) was a veteran Communist insider. Born Chaim Rakeover in 1873, he studied medicine in France before becoming a revolutionary. He was the leader of a terror group that attacked government officials.

In 1919, Lenin put him in charge of the Soviet Ukraine government. He retained the territory for the Bolsheviks during the Civil War. Stalin appointed him Russian ambassador to Paris in 1925.

Rakovsky belonged to the powerful Trotskyite faction that took their orders from the Rothschilds. Many of this group were shot in Stalin’s 1937 Communist Party purge.

## **MIDNIGHT INTERROGATION**

The circumstances of the midnight interrogation Jan. 26, 1938 were very dramatic.

*What could Rakovsky possibly say to save his life?*

Rakovsky appears to use the tactic of “deceiving with the truth.” He wins trust by revealing the truth but leaves some out. He impresses his interrogator that he and Trotsky represent an invincible power he calls

the “*Capitalist-Communist Financial International*.”

He confirms that the “revolutionary movement” was designed to enlist support by pretending to serve mankind’s moral and collective ideals. The real aim however is to give total world power to the bankers by dividing society and undermining established authority.

“Revolution” really means, “overturning” Western civilization.

“Christianity is our only real enemy since all the political and economic phenomena of the bourgeois states are only its consequences,” Rakovsky, says. (All page citations from Griffin, *Fourth Reich of the Rich*, 1988, p. 264)

Peace is “counter-revolutionary” since it is war that paves the way for revolution.

Rakovsky, whose tongue was loosened by a mild inebriant in his wine, refers to the Illuminati as “they” or “them.” He is a member although not part of the inner circle.

He explains that the “Illuminati” is a Masonic secret society dedicated to Communism. Significantly, its founder Adam Weishaupt took the name from “the second anti-Christian conspiracy of that era, gnosticism.” (249)

## **HOW THIS GRIPPING ACCOUNT SURFACED**

The interrogator was one of Stalin’s cleverest agents, Gavril Kus’min known as “Gabriel.”

Apart from a hidden sound technician, a doctor Jose Landowsky was the only other person present.

Conscripted by the NKVD to help “loosen the tongues of detainees,” Dr. Landowsky was sickened by the many tortures he witnessed.

The interrogation of Rakovsky, however, was cordial. Dr. Landowsky doubts if the mild euphoric he put in Rakovsky’s drink had much effect.

The interrogation, conducted in French lasted from midnight until 7 a.m. Afterward, Kus’min ordered Landowsky to translate the interview into Russian and make two copies.

The content was so mind boggling that Landowsky made an additional carbon for himself. “I am not sorry that I had the courage for this,” he wrote. (279) (The Bolsheviks had shot Landowsky’s father, a Tsarist colonel, during the 1917 revolution.)

A Spanish Fascist volunteer later found the manuscript on Landowsky’s dead body in a hut on the Petrograd front during World War Two. He took it back to Spain where it was published as “*Sinfonia en Rojo Mayo*.” in 1949.

## **REVELATIONS**

Rakovsky gives his interrogator an astonishing inside view of modern history in order to prove that his sponsors control the world.

“Money is the basis of power,” Rakovsky says, and the Rothschilds manufacture it thanks to the banking system.

The “Revolutionary Movement” was an attempt by Meyer Rothschild and his allies to protect and extend this monopoly by establishing a totalitarian New World Order.

According to Rakovsky, “The Rothschilds were not the treasurers, but the chiefs of that first secret Communism...Marx and the highest chiefs of the First International ... were controlled by Baron Lionel Rothschild, [1808-1878] whose revolutionary portrait [“Sidonia”] was done by Disraeli the English Premier, who was also his creature, and has been left to us [in Disraeli’s novel ‘*Coningsby*.’]” (250)

Lionel’s son Nathanael (1840-1915) needed to overthrow the Christian Romanoff Dynasty. Through his agents Jacob Schiff and the Warburg brothers, he financed the Japanese side in the Russo Japanese War, and an unsuccessful insurrection in Moscow in 1905. Then he instigated the First World War (Trotsky was behind the murder of Archduke Ferdinand) ;and financed the 1917 Bolshevik Revolution. Rakovsky says he was personally involved in the transfer of funds in Stockholm. (251-252)

The Jewish labour movement or “Bund” was Rothschild’s instrument. The Bund’s “secret faction” infiltrated all the socialist parties in Russia and provided the leadership for the Russian Revolution. Alexander Kerensky, the Menshevik Prime Minister was a secret member. (253)

Leon Trotsky was supposed to become the leader of the USSR. Trotsky, a Jew, married the daughter of one of Rothschild’s closest associates, banker Abram Zivotovsky and became part of the “clan.”

Unfortunately “national” Communists like Lenin (one-quarter Jewish) got in the way. Lenin overruled Trotsky and made peace with Germany (Treaty of Brest Litovsk, 1918.) This was not the Rothschild’s plan.

World War One was supposed to end the way the Second World War did. Russia was supposed to overrun Germany in 1918 and assist local “revolutionaries” in establishing a “peoples’ republic.”

Trotsky was responsible for an attempt to assassinate Lenin in 1918 but Lenin survived. When Lenin had a stroke in 1922, Trotsky had Levin, Lenin’s Jewish doctor, finish him off.

At this critical moment, the unexpected happened. Trotsky got sick and Stalin was able to take power. At this crucial juncture, the Trotskyites pretended to support Stalin and infiltrated his regime in order to sabotage it.

Rakowsky characterizes Stalin as a “Bonapartist,” a nationalist as opposed to an International Communist like Trotsky who served the banker agenda.

“He is a killer of the revolution, he does not serve it, but makes use of its service; he represents the most ancient Russian imperialism, just as Napoleon identified himself with the Gauls...” (257)

## **CONTAINING STALIN**

In order to control Stalin, international finance was forced to build up Hitler and the Nazi party. Rakowsky confirms that Jewish financiers backed the Nazis although Hitler supposedly was not aware of this.

“The [ambassador Warburg](#) presented himself under a false name and Hitler did not even guess his race... he also lied regarding whose representative he was... Our aim was to provoke a war and Hitler was

war...[the Nazis] received...millions of dollars sent to it from Wall Street, and millions of marks from German financiers through Schacht; [providing] the upkeep of the S.A and the S.S. and also the financing of the elections..." (259-260)

Unfortunately for the bankers, Hitler also proved intractable. He started to print his own money!

**"He took over for himself the privilege of manufacturing money and not only physical moneys, but also financial ones; he took over the untouched machinery of falsification and put it to work for the benefit of the state... Are you capable of imagining what would have come ...if it had infected a number of other states and brought about the creation of a period of autarchy [absolute rule, replacing that of the bankers]. If you can, then imagine its counterrevolutionary functions..." (263)**

Hitler had become a bigger threat than Stalin, who had not meddled with money. Rakovsky's present mission was to convince Stalin to make a pact with Hitler and turn Hitler's aggression against the West. The purpose was for Germany and the Western nations to exhaust each other before second front was opened in the East.

[According to Walter Kravitsky, the head of Soviet Military Intelligence in Europe who defected to the West and was later assassinated in 1941, Stalin was determined to make a pact with Hitler as early as 1934. He had no desire to fight the Nazis. Is it possible Rakovsky and his sponsors did not know this? Kravitsky *On Stalin's Secret Service* (1939)]

Rakovsky urged the Russians to use the tactic of "deceiving with the truth." The Russians were to impress Hitler with their genuine desire for peace. Hitler was not to suspect that he was being set up for a war on two fronts.

Stalin was given a choice. If he agreed to divide Poland with Hitler, the West would declare war on *only one* aggressor, Germany. If he refused, the bankers would allow Hitler to depose him.

Kus'min demanded some high level confirmation. Rakovsky told him to see Joseph Davies, the US ambassador in Moscow, a fellow Freemason and representative of the International Communist Roosevelt administration.

Someone was sent to Davies who confirmed that "much would be gained" if Rakovsky got an amnesty. On March 2, 1938, a powerful radio message was sent to Moscow in the cipher of its London embassy. "Amnesty or the Nazi danger will increase," it said. Davies attended Rakovsky's trial and gave him a Masonic greeting. On the same day, March 12, 1938, Hitler marched into Austria.

Rakovsky's death sentence was commuted. Some believe he lived out his years under an assumed name. Another source has him shot in 1941.

Secret negotiations were begun with Hitler. The result was the Ribbentrop-Molotov pact signed in August 1939 just one week before the invasion of Poland.

The interrogation seems to have created an accord between Stalin and the Illuminati.

Rakovsky told Kus'min that the Illuminati never take political or financial positions. They use "intermediaries."

"Bankers and politicians are only men of straw.... even though they occupy high places and appear to be

1901: The Jews from the colonies set up in Palestine by Edmond James de Rothschild, send a delegation to him which tell him, "If you wish to save the Yishuv (The Jewish settlement) first take your hands from it, and for once permit the colonists to have the possibility of correcting for themselves what needs correcting." Edmond James de Rothschild is very angry about this and states, "I created the Yishuv, I alone. Therefore no men, neither colonists nor organisations have the right to interfere in my plans." The Rothschild banking-house in Frankfurt, Germany, M. A. von Rothschild und Söhne, closes as there is no male Rothschild heir to take it on. 1902: Philippe de Rothschild born.

1905: A group of Rothschild backed Zionist Jews led by Georgi Apollonovich Gapon attempt to overthrow the Tsar in Russia in a Communist Coup. They fail and are forced to flee Russia only to be given refuge in Germany.

The Jewish Encyclopaedia (Vol. 2, p.497) states, "It is a somewhat curious sequel to the attempt to set up a Catholic competitor to the Rothschilds that at the present time the latter are the guardians of the papal treasure."

1906: The Rothschilds claim that due to growing instability in the region and increasing competition from Rockefeller (the Rockefeller family are Rothschild descendants through a female bloodline) owned Standard Oil, this is why they sell their Caspian and Black Sea Petroleum Company to Royal Dutch and Shell. This is another example of the Rothschilds trying to hide their true wealth.

1907: Rothschild, Jacob Schiff, the head of Kuhn, Loeb and Co., in a speech to the New York Chamber of Commerce, warns that, "Unless we have a Central Bank with adequate control of credit resources, this country is going to undergo the most severe and far-reaching money panic in its history." Suddenly America finds itself in the middle of another typical run of the mill Rothschild-engineered financial crisis, which ruins as usual ruins the lives of millions of innocent people throughout America and makes billions for the Rothschilds.

1909: Jacob Schiff founds the National Advancement for the Association of the Coloured People (NAACP). This was done to incite black people into rioting, looting and other forms of disorder, in order to cause a rift between the black and white communities. Jewish historian, Howard Sachar, states the following in his book, "A History of the Jews in America," "In 1914, Professor Emeritus Joel Spingarn of Columbia University became chairman of the NAACP and recruited for its board such Jewish leaders as Jacob Schiff, Jacob Billikopf, and Rabbi Stephen Wise." Other Ashkenazi Jew co-founders included Julius Rosenthal, Lillian Wald and Rabbi Emil G. Hirsch. It was not until 1920 that the NAACP appointed its first black president, James Weldon Johnson. Maurice de Rothschild marries Ashkenazi Jew, Noémie Halphen.

1911: Werner Sombart, in his book, "The Jews and Modern Capitalism," stated that from 1820 on, it was the, "Age of the Rothschild," and concluded that there was, "Only one power in Europe, and that is Rothschild."

1912: In the December issue of, "Truth," magazine, George R. Conroy states of banker Jacob Schiff, "Mr Schiff is head of the great private banking house of Kuhn, Loeb, and co, which represents the Rothschilds interests on this side of the Atlantic. He has been described as financial strategist and has

been for years the financial minister of the great impersonal power known as Standard Oil." He was hand in glove with the Harrimans, the Goulds, and the Rockefellers in all their railroad enterprises and has become the dominant power in the railroad and financial power of America."

1913: On March 4, Woodrow Wilson is elected the 28th President of the United States. Shortly after he is inaugurated, he is visited in the White House by Ashkenazi Jew, Samuel Untermyer, of law firm, Guggenheim, Untermyer, and Marshall, who tries to blackmail him for the sum of \$40,000 in relation to an affair Wilson had whilst he was a professor at Princeton University, with a fellow professor's wife. President Wilson does not have the money, so Untermyer volunteers to pay the \$40,000 out of his own pocket to the woman Wilson had had the affair with, on the condition that Wilson promise to appoint to the first vacancy on the United States Supreme Court a nominee to be recommended to President Wilson by Untermyer. Wilson agrees to this. Jacob Schiff sets up the Anti Defamation League (ADL) in the United States. This organisation is formed to slander anyone who questions or challenges the Rothschild global conspiracy as, "anti-semitic." Strangely enough, the same year that they do this they also set up their last and current central bank in America, the Federal Reserve. Congressman Charles Lindbergh stated following the passing of the Federal Reserve Act on December 23, "The Act establishes the most gigantic trust on earth. When the President signs this Bill, the invisible government of the monetary power will be legalized.....The greatest crime of the ages is perpetrated by this banking and currency bill." It is important to note that the Federal Reserve is a private company, it is neither Federal nor does it have any Reserve. It is conservatively estimated that profits exceed \$150 billion per year and the Federal Reserve has never once in its history published accounts.

1914: The start of World War I. In this war, the German Rothschilds loan money to the Germans, the British Rothschilds loan money to the British, and the French Rothschilds loan money to the French. Furthermore, the Rothschilds have control of the three European news agencies, Wolff (est. 1849) in Germany, Reuters (est. 1851) in England, and Havas (est. 1835) in France. The Rothschilds use Wolff to manipulate the German people into a fervour for war. From around this time, the Rothschilds are rarely reported in the media, because they own the media.

1916: On June 4, Ashkenazi Jew, Louis Dembitz Brandeis is appointed to the Supreme Court of the United States by President Wilson as per his agreed blackmail payment to Samuel Untermyer some three years earlier. Justice Brandeis is also the elected leader of the Executive Committee for Zionist Affairs, a position he has held since 1914. The middle of World War II Germany was winning the war as they were being financed by the Rothschilds to a greater extent than France, Italy and England, because Rothschilds, did not want to support the Tsar in Russia, and of course Russia was on the same side as France, Italy and England. Then a significant event occurred. Germany, although they were winning the war and not one foreign soldier had set foot on their soil, offered armistice to Britain with no requirement of reparations. The Rothschilds were anxious to make sure this didn't happen as they were expecting to make far more money off this war, so they played another card they had up their sleeve.

Whilst the British were considering Germany's offer, Rothschild agent Louis Brandeis sends a Zionist delegation from America to Britain to promise to bring America into the war on the side of the British, provided the British agree to give the land of Palestine to the Rothschilds. The Rothschilds wanted Palestine for the following reason: They had great business interests in the far east and desired their own state in that area along with their own military which they could use as an aggressor to any state that threatened those interests. The British subsequently agree to the deal for Palestine and the Zionists in London contact their counterparts in America and inform them of this fact. Suddenly all the major newspapers in America that up to that point had been pro-German turned on Germany running propaganda pieces such as: German soldiers were killing Red Cross Nurses; German soldiers were cutting off babies hands, etc, in order to manipulate the American public against the Germans.

This same year, President Woodrow Wilson, ran a re-election campaign under the slogan, "Re-Elect The Man Who Will Keep Your Sons Out Of The War."

On December 12, Germany and her allies offer peace terms to end the war.

1917: As a result of Germany's offer of peace the Rothschild war machine goes into overdrive in America, spreading propaganda which leads to President Wilson under the instructions of American Zionist leader and Supreme Court Justice, Louis Dembitz Brandeis, reneging on his promise to the electorate and taking America into the first world war on April 6. As per the Rothschild Zionist promise to the British, to take America into the war, they decide they want something in writing from the British to prove that they will uphold their side of the bargain. The British Foreign Secretary, Arthur James Balfour therefore drafts a letter which is commonly known as the, "Balfour Declaration," which is reprinted below.

Foreign Office November 2nd, 1917

Dear Lord Rothschild,

I have much pleasure in conveying to you, on behalf of His Majesty's Government, the following declaration of sympathy with Jewish Zionist aspirations which has been submitted to, and approved by, the Cabinet.

His Majesty's Government view with favour the establishment in Palestine of a national home for the Jewish people, and will use their best endeavours to facilitate the achievement of this object, it being clearly understood that nothing shall be done which may prejudice the civil and religious rights of existing non-Jewish communities in Palestine, or the rights and political status enjoyed by Jews in any other country.

I should be grateful if you would bring this declaration to the knowledge of the Zionist Federation.

The Rothschilds order the execution by the Bolsheviks they control, of Tsar Nicholas II and his entire family in Russia, even though the Tsar had already abdicated on March 2. This is both to get control of the country and an act of revenge for Tsar Alexander I blocking their world government plan in 1815 at the Congress Of Vienna, and Tsar Alexander II siding with President Abraham Lincoln in 1864. It is extremely important for them to slaughter the entire family including women and children in order to make good on the promise to do so made by Nathan Mayer Rothschild in 1815. It is designed to show the world what happens if you ever attempt to cross the Rothschilds. (NB. Anastasia escaped this attack)

U.S. Congressman Oscar Callaway informs Congress that J. P. Morgan is a Rothschild front and has taken control of the American media industry. He states, "In March, 1915, the J.P. Morgan interests, the steel, shipbuilding, and powder interest, and their subsidiary organizations, got together 12 men high up in the newspaper world and employed them to select the most influential newspapers in the United States and sufficient number of them to control generally the policy of the daily press... They found it was only necessary to purchase the control of 25 of the greatest papers...An agreement was reached. The policy of the papers was bought, to be paid for by the month, an editor was furnished for each paper to properly supervise and edit information regarding the questions of preparedness, militarism, financial policies, and other things of national and international nature considered vital to the interests of the purchasers."

1919: In January, Ashkenazi Jews, Karl Liebknecht and Rosa Luxemburg, are killed as they attempt to lead another Rothschild funded Communist coup, this time in Berlin, Germany. The Versailles peace



conference is held to decide reparations that the Germans need to pay to the victors following the end of the first world war. A delegation of 117 Zionists headed up by Ashkenazi Jew, Bernard Baruch, bring up the subject of the promise of Palestine for them. At this point the Germans realised why America had turned on them and under whose influence, the Rothschilds.

The Germans, naturally, felt they had been betrayed by the Zionists. This is because, at the time the Rothschilds made their deal with Britain for Palestine, in exchange for bringing America into the war, Germany was the most friendly country in the world towards the Jews, indeed the German Emancipation Edict of 1822 guaranteed Jews in Germany all civil rights enjoyed by Germans. Also, Germany was the only country in Europe which did not place restrictions on Jews, even giving them refuge when they had to flee from Russia after their first attempted Communist coup failed there in 1905.

Nevertheless, the Rothschilds had held up their side of the bargain to spill the blood of millions of innocents and as a result, Palestine is confirmed as a Jewish homeland, and whilst its handover to the Rothschilds takes place it is to remain under the control of Britain as the Rothschilds control Britain. At that time less than one percent of the population of Palestine was Jewish. Interestingly, the host of the Versailles peace conference is its boss, Baron Edmond de Rothschild. The Versailles peace conference is also used as an attempt by the Rothschilds to set up a world government under the pretext of ending all wars (*which they create*). This was called the, "League of Nations." Fortunately not enough countries accepted it and so it soon died.

On March 29th The Times of London reports on the Bolsheviks in Russia, "One of the curious features of the Bolshevik movement is the high percentage of non-Russian elements among its leaders. Of the twenty or thirty commissaries, or leaders, who provide the central machinery of the Bolshevik movement, not less than 75% were Jews." It is reported that the Rothschilds were angry with the Russians because they were not prepared to allow them to form a central bank within their nation. They therefore gathered groups of Jewish spies and sent them into Russia to drum up a revolution for the benefit of the common man, which was actually a takeover of Russia by a Rothschild-controlled satanic elite. These Jewish spies were, in age-old deceptive Ashkenazi tradition, given Russian names, for example Trotsky was a member of the first group and his original name was Bronstein. These groups were sent to areas throughout Russia to incite riots and rebellion. The Jewish Post International Edition, week ending January 24th 1991, confirms Vladimir Lenin was Jewish. Lenin is also on record as having stated, "The establishment of a central bank is 90% of communizing a nation." These Jewish, Rothschild funded Bolsheviks would go on in the course of history to slaughter 60 million Christians and Non-Jews in Soviet controlled territory. Indeed the author Aleksandr Solzhenitsyn in his work, "Gulag Archipelago, Vol 2," affirms that Zionist Jews created and administered the organized Soviet concentration camp system in which these tens of millions of Christians and Non-Jews died. On page 79 of this book he even names the administrators of this the greatest killing machine in the history of the world. They are Aron Solts, Yakov Rappoport, Lazar Kogan, Matvei Berman, Genrikh Yagoda, and Naftaly Frenkel. All six are Zionist Jews. In 1970 Solzhenitsyn would be awarded the Nobel Peace Prize for literature.

N. M. Rothschild & Sons' are given a permanent role to fix the world's daily gold price. This takes place in the City of London offices, daily at 1100 hours, in the same room until 2004.
